Dear Commissioner Schmit,

We are writing you as providers of social services, human rights organizations, organizations working with children and young people, representatives of the academic sector, public administration and people with experience of homelessness or users of social services. We are concerned about the process of preparing the distribution of ESIF allocations in the Czech Republic for the next programming period and we want to ask you for the support and firm position of the EC in negotiating allocations with the Czech government.

The Czech Republic still faces a number of social challenges, such as **under-representation of women with children and vulnerable groups in the labor market, regional poverty concentration and growth in socially excluded localities, over-indebtedness, homelessness and housing exclusion, population aging, predominance of institutional care over community support, and other structural problems**. The European Social Fund in the Czech Republic significantly contributes to the progress in solving these problems: It helped to create 1,500 children's groups for 20,000 children and micro-nurseries. European funds have helped to ensure that children without families do not have to grow up in orphanages, to the transformation of mental health care, to support the integration of the Roma population. The OPZ program educates 3,000 nurses and 1,250 medical staff and pharmacists. OPZ also helps in supporting the solution of homelessness, victims of crime, or single parents. In many respects, ESF funds in the Czech Republic provide basic public services.

Developments in recent weeks have shown that the Czech government is not fully aware of the seriousness of the social situation and the need for ESF funding. On 14 October 2020, a proposal for the allocation of ESIF funds for the 2021–2027 programming period was submitted to the Government of the Czech Republic, which reduced support from the originally proposed EUR 1.6 billion to EUR 1 billion. Investments in social peace and cohesion were to be largely replaced by investments in concrete without any justification. This proposal was not accepted by the government, but a month later the members of the Monitoring Committee of the Operational Program Employment were informed that the ESF+ allocation will be reduced by 10% (in favor of the Cohesion Fund) and that the OPZ+ program will now be further prepared. None of the proposals was based on any analyses or strategic documents of the Czech Republic and the EU.

We consider the reduction to be inadequate for three main reasons. Firstly, a large part of the social problem still persists and now is certainly not a good time to slow down in their efforts to solve them. Secondly, as a result of the COVID 19 pandemic, we expect the economic situation of many people to deteriorate due to the negative effects of the incipient economic crisis. These people will need social services and employment support to avoid falling into long-term poverty and social exclusion. The third reason for maintaining the allocation is the aging of the population and the new possibility to finance projects for seniors from ESF+ resources.

Random and unjustified changes in the long-term planned allocations for the 2021–2027 programming period before its start are, in our view, inadmissible. In addition to myopia when preferring to invest in concrete over people, there is a risk of serious problems with drawing ESIF funds, because reallocation proposals are not accompanied by a quality assessment of absorption capacity. If the Czech Republic decides during the next programming period for partial reallocations, either due to poor drawing in a specific area or unexpected events, it is, in our opinion, legitimate, but the changes proposed now are not legitimate.

Dear Commissioner Schmit,

we believe that, like us, you are aware of the need to continue structural changes in the social field in the Czech Republic, as well as the future risks of demographic and economic development. We would therefore like to ask you to use all your possibilities to maintain or increase the ESF + allocation in the Czech Republic for the next programming period.
