More attention for the rural population!

Versatile work of the Czech ESU Association

Prague. The Czech Christian Seniors' Organization (SKS) is participating in a project of EAPN Czech Republic aimed at helping seniors in small towns and villages. President **Lidmila Nemcova** reports: "big cities offer better services than small ones. A report has specified the weaknesses. It is proposed that in future, an authorised representative should take care of the concerns of the elderly in a number of small villages", because: "the quality of life of the elderly also depends on the support of local authorities. It's not just about material help, it's also about personal attention."

In addition, this year SKS was active in an EAPN project dedicated to combating poverty and social exclusion in **Latvia**. The SKS President also joined the Czech delegation traveling to Riga for this purpose. Thanks to the support of **Dr. Guna Putnina**, head of Latvia's Christian Democratic Seniors' Association, and of **Andrejs Rudzitis**, interesting panel discussions were held which served a better understanding of the situation in both countries. It was established that there are similar obstacles to overcome. Lidmila Nemcova hopes for a continuation of the relationship and states: "the situation of (the elderly citizen) is similar in all post-communist countries."

To the delight of the SKS President, in November several members of her seniors' organization won a mandate in the Czech municipal elections in the local councils.

Sebastian Kurz: facilitate growing old with dignity

Austrian Federal Chancellor expresses himself in newsletter to the ÖSB

Vienna. "For the first time in many years, the pension will be increased significantly" writes Federal Chancellor Kurz in the newsletter of the seniors' association, which its President, **Ingrid Korosec**, distributes. In 2019, it will provide the largest increase of the past years, which will be well above the 2% inflation rate for small and medium retirement pensions. "People should get the appreciation they deserve for their lifelong work."

"A major issue, for which politics has yet to find a solution, is in the field of care," **Kurz** writes further. A reform is now being worked out to enable people to have "high-quality care and ageing in dignity". That the citizens are getting older is positive. Of course, that will lead to new challenges. The reform will therefore pay particular attention to the sustainable financing for care and for the training of qualified personnel. "Our aspiration is furthermore to enable people to live in their own home for as long as possible. This requires better support for family carers and caregivers," it concludes.

Longing for peace and prosperity

Impressions from a journey through the Western Balkan countries

Western Balkans region. If you visit Croatia, Bosnia and Herzegovina as well as Montenegro today, you will notice one thing above all else: a longing and striving for a peaceful life in freedom and prosperity is one of the most pressing concerns. Much more pronounced here than elsewhere in Europe, because the "Yugoslavia wars" (locally called the "homeland wars") of the '90s killed approximately 100,000 people, wiped out many families, caused huge material damage, adversely affected centuries of human relationships or completely destroyed them. The fact that things are now peaceful in the countries visited is a miracle after the mutual attacks and bombings. And all the more since there have always been different peoples, cultures, languages and religions here.

The “Stari Most” (“Old Bridge”) from the 16th century (a UNESCO World Heritage Site) over the river Neretva, rebuilt in 2004, is now an important link between the Christian (Catholic and Greek Orthodox) and Muslim, or respectively Croatian and Bosnian-influenced parts of the city. People visit each other, as they say. A 1993 plaque commemorates the destruction of the world-famous building on 9th November 25 years ago, presumably by the Croatian artillery.

In Dubrovnik, Croatia, a memorial commemorates the names of the 200 soldiers killed during those terrible times.

Here in Montenegro, the southernmost and smallest of the West Balkan countries visited, one pays with EURO; neighbouring Bosnia and Herzegovina, on the other hand, is not part of the Eurozone (currency: Convertible Mark of 100 Fening) or the EU, and while Croatia still has the Kuna as its currency, it has already achieved the desired goal of becoming a member of the EU. Montenegro is currently being granted the greatest opportunity to meet the European Union's admission criteria.

Up to now, the European Seniors' Union has a member association in Croatia with which, regrettably, there is no contact at present.

The Adriatic coast is rich in UNESCO World Heritage Sites and natural wonders, which are always worth a visit. For example, with RSD (Reise Service Deutschland - "German travel service"), which meets the needs of older citizens above all with its offers in the winter season, and secures jobs in the catering, hotel and tourism industries. RSD has the most important tourist attractions in its programme and provides knowledgeable and dedicated tour guides. Most booked hotels are accessible to the disabled.

"Power Woman" Marianne Thyssen

Brussels. European Commissioner Marianne Thyssen was honoured as an extraordinary political leader on 13th December as "Woman in Power 2018". She herself distinguished the city of Breda (NL) with the Access City Award 2019 for its ongoing efforts to provide accessibility for the disabled. 2nd and 3rd place went to Evreux (F) and

Gdynia (PL). 52 municipalities took part in the competition. 80 million disabled citizens live in Europe.

Congratulations from the President to Spain

Brussels/Madrid. On the occasion of the 40th anniversary of the democratic constitution of Spain, ESU President **An Hermans** congratulated the Vice-president in Madrid, **Carmen Quintanilla Barba**. The congratulations also relate to her initiative to use the event as occasion for a congress of the rural women's organisation, Afammer. This Association has about 180,000 members. The President regrets that she could not take up the invitation.
